RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to practice, compete, officiate, observe, work for, or participate in any way in an official or unofficial organized or unorganized PRACTICE, or EVENT(S) or being permitted to enter for any purpose any RESTRICTED AREAS (defined as any area requiring special authorization such as but not limited to the Snake River Karters asphalt track and grounds, credentials, or permission to enter any area to which admission by the general public is restricted or prohibited), THE UNDERSIGNED, for himself, his personal representatives, heirs, and next of kin:

1. Acknowledges, agrees, and represents that he has or will immediately or upon entering any of such RESTRICTED AREAS (such as but not limited to the Snake River Karters asphalt track and grounds), which he enters and he further agrees and warrants that, if at any time, he is in or about RESTRICTED AREAS (such as but not limited to the Snake River Karters asphalt track and grounds) and he feels anything to be unsafe, he will immediately advise the Snake River Karters officials of such and will leave the RESTRICTED AREAS (such as but not limited to the Snake River Karters asphalt track) and/or refuse to participate further in the PRACTICE, or the EVENT(S). I HAVE READ AND UNDERSTAND: _____

2. HEREBY RELEASES, WAIVES, DISCHARGES AND COVENANTS NOT TO SUE the promoters, participants, racing associations, sanctioning organizations or any subdivision thereof, track operators, track owners, officials, car owners, go kart owners, drivers, pit crews, rescue personnel, any persons in any RESTRICTED AREAS (such as but not limited to the Snake River Karters asphalt track and grounds), promoters, sponsors, advertisers, Snake River Karters, owners and lessees of premises used in an official or unofficial organized or unorganized PRACTICE, or EVENT(S) and each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "RELEASEES", FROM ALL LIABILITY, TO THE UNDERSIGNED, his personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO OFFICIAL OR UNOFFICIAL ORGANIZED OR UNORGANIZED PRACTICE OR EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I HAVE READ AND UNDERSTAND: _____

3. HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the Releases and each of them FROM ANY LOSS, LIABILITY, DAMAGE, OR COST they may incur arising out of or related to OFFICIAL OR UNOFFICIAL ORGANIZED OR UNORGANIZED PRACTICE OR EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I HAVE READ AND UNDERSTAND: _____

4. HEREBY ASSUMES FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH, OR PROPERTY DAMAGE arising out of or related to OFFICIAL OR UNOFFICIAL ORGANIZED OR UNORGANIZED PRACTICE OR EVENT(S), WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. I HAVE READ AND UNDERSTAND: _____

HEREBY agrees that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the Releases, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the OFFICIAL OR UNOFFICIAL ORGANIZED OR UNORGANIZED PRACTICE OR EVENT(S) is/are conducted and that in any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect. I HAVE READ AND UNDERSTAND: _____
